Anyone who submits a VU scholarship application will be considered for an award. All scholarship categories will be considered by a committee that will review your qualifications. The committee's goal is to distribute more than \$1,000,000 to those who are most qualified and/or most in need. A majority of the scholarships are restricted to the Vincennes campus; however, some, including all of the academic scholarships, also apply to the Aviation Technology Center, Jasper Campus, and the American Sign Language Program. Though you may receive multiple awards, you can only receive one academic scholarship. We also highly recommend that every family submit a FAFSA each year, even if you do not feel you will qualify for federal or state grant aid.

Priority Deadlines: Vincennes University applications - January 15; FAFSA - March 10.
