VU intends to administer 100% of the portion designated as emergency financial aid grants to students.
- 2. Total amount of the CRRSSA funds we will receive or have received from the Department for emergency grants for students totals \$2,433,264.
 - Total amount of the ARP funds we will receive or have received from the Department for emergency grants for students totals \$9,302,533.
- 3. Total amount of CRRSAA Act emergency grant funds distributed to date is \$2,433,264 (all funds have been spent); and the total amount of ARP Act emergency grant funds distributed to date is \$8,833,711.

Awards were distributed to students who were registered as April 13, 2021 and eligible for Federal Title IV Financial Aid at that time. For Summer Term 2021, grants were distributed in a formulated approach based on enrollment and Pell Grant eligibility as determined by the submission of the 2020-2021 FASFA. Awards were distributed to all eligible students who were registered at the time of distribution.

For Fall Term 2021, grants will be distributed in a formulated approach based on enrollment and Pell Grant eligibility as determined by the submission of the 2021-2022 FASFA. Awards will be distributed to all eligible students who complete a questionnaire and who are registered at the time of the distribution of funds.

For Spring Term 2022, grants will be distributed in a formulated approach based on enrollment and Pell Grant eligibility as determined by the submission of the 2021-2022 FASFA. Awards will be distributed to all eligible students who complete a questionnaire and who are registered at the time of the distribution of funds.

- 1. Vincennes University acknowledges that we have signed and returned to the Department the Certification and Agreement. VU intends to use no less than 50% of the funds under the CARES Act as emergency financial aid grants to students.
- 2. Total amount of funds we will receive or have received from the Department for emergency grants for students totals \$2.433.264.
- 3. Total amount of CARES Act emergency grant funds distributed to date is \$2,433,264.
- 4. The estimated total number of students eligible for Title IV aid and thus eligible for emergency grants for students is 2.808.
- 5. The total number of students who have received an emergency grant under the CARES Act totals 2,798.
