# 1) Byron R. Lewis Papers

Fine collection of letters, documents, notes, and account books of Byron R. Lewis, Bridgeport, Illinois, and founder of the Lewis Historical Library. Collection ranges over a wide variety of subjects on genealogy and local history. (See finding aid.)

2) Henry S. Cauthorn Papers (1828-1905)

Papers of Henry S. Cauthorn, prominent resident of Vincennes. Served in the Indiana House of Representatives, 1870-1880. Collection of personal papers and business receipts. Also several letters of Alice Cauthorn, daughter of Henry. (See finding aid.)

3) John F. Bayard (1786-1853)

Legal papers of a prominent Vincennes resident. Some early French documents, some translated. Many indentures and land deeds. (See finding aid.)

4) Howard Burnett

Vincennes High School History Teacher. Wrote much on history of Vincennes University, First Methodist Church, James D. "Blue Jeans" Williams, Governor of Indiana. Contains history research notes and articles. (See finding aid.)

5) Allen Family Papers

Papers of Cyrus M. Allen, Cyrus M. Allen, Jr., Ann Eastham Allen, Mary Lloyd Allen (Johnson), Ann Allen Johnson (Renick), William Nelson Johnson, Jr., Orrill G. Thompson. Includes documents pertaining to the case of the Vincennes Steam Mill, 1817-1879. (See finding aid.)

6) John Badollet Papers

Correspondence of John Badollet (1758-1837) and his son, Albert. Badollet was the first Land Registrar of Vincennes. Most of the letters are in French. Contains Journal of trip to s.w. Pennsylvania in 1792-1794. Additional Badollet correspondence is included, as well. (See Indiana Memory digitized collection.)

7) George Dunn (1812-1857) Papers, 1837-1887

Letters and legal papers of an Indiana Congressman, who was elected as a Whig in 1847. Some political interested scattered throughout collection. Letters of Judge David McDonald.

8) LaCroix Family Papers (1833-1893)

Business records of a general store in Vincennes, Indiana. Variety of receipts listing prices of goods brought by steamboat and railroad. Store owned by Marcel and John D. LaCroix. (See finding aid.)

9) Elihu Stout (1782-1860) papers, 1820-1860

Business receipts of Elihu Stout, owner of the Western Sun newspaper, Vincennes, Indiana. Receipt showing prices paid for advertising.

10) Thomas Leavery

Document, 1809 Deed of Conveyance for 100 acres of land. (See finding aid.)

11) William Thomas

Letter, 1836. Letter of William Thomas to relatives telling of economic conditions in central Illinois in 1836. (See finding aid.)

12) Watts Family Papers, 1928-1964

Collection of a variety of resource materials on the history of Vincennes by Harry T. and Florence G. Watts. Correspondence notes, articles, copies of original maps, letters, etc. (See finding aid.)

13) Vincennes Steam Mill 1818-1830

Letters and documents concerning early steam mill in Vincennes, Indiana. (See finding aid.)

14) Maurice Thompson

Letter, 1889. Collection contains one short poem and letter to "Hon. W. E. Ambler," written at Crawfordsville, May 28, 1889. (See finding aid.)

15) John Ewing

Papers, 1815-1840. Indentures and tax receipts on land owned in Illinois of a prominent Vincennes merchant and public official. (See finding aid.)

16) Belle of Fountain Log Book, 1885

Log book of the Steamer Belle of Fountain that plied between Terre Haute and Vincennes in the mid-1880s. List of passengers, goods, and fees charged.

17) Myron P. Boehm – GRC – Approach to Vincennes

A paper written by Boehm on George Rogers Clark's approach march to Vincennes, in 1779. (Moved to RHC #602.)

18) G. Conrad Papers, 1856

Daily orders of a Maysville, Indiana, general store. Order shows date of purchase, items and price, and name of purchaser. (See finding aid.)

19) Horace Hardy Lester

Articles written by Lester who was nationally known for his work in the field of physics. He was a graduate of Vincennes University in 1904. (See finding aid.)

20) Ernest P. Bicknell (1862-1929)

Autobiographical sketch of a Knox County resident. Describes growing up in the Freelandville, Indiana, area. (See finding aid.)

21) Allie Arnold (1889-1971)

Papers, 1950-1970. Newspaper articles and radio scripts of a long-time resident of Vincennes. Much on local names and places. (See finding aid.)

22) Busseron's Account Book

Account book, 1777-1782. Account book of Francis Busseron, merchant of Vincennes, Indiana at the time of Clark's capture of Ft. Sackville. In French and English.

23) Norman F. Arterburn

Papers, 1934. Letter from Austin Stults of the Lincoln National Life Insurance Company inviting Judge Arterburn to visit the Lincoln Museum. (See finding aid.)

24) Lewis Family Papers, 1850-1920

Letters of Perry Lewis family of Lawrenceville, Illinois. Letters from brother Philip Lewis written from Gold Fields in California and Wisconsin in mid-1850s. (See finding aid.)

25) Niemann, Simpson, and Kelso Papers

Correspondence, 7/9/1889-.; business records; legal documents. (See finding aid.)

- 26) Meeks Family (Ralph Meeks, 1887-)
  - Papers, 1946-1963. Collection of personal and official correspondence of a board member and secretary of the Lincoln Free Press Association. Shows growth and development of Association.
- 27) Henry Cullison

Letter, 1862. Letter from Cullison, stationed in Mississippi, to a friend agreeing to pay \$3.00 per acre to have his wheat crop cleared. (See finding aid.)

28) Louis Hendrickson

Letter, 186, from Hendrickson to his mother in St. Louis. (See finding aid.)

- 29) Roughan Grocery Co.
  - 1926 Invoices of the Roughan Grocery Company, Lawrenceville, Illinois, showing produce bought and price. (See finding aid.)
- 30) Valentine Papers (socialist)

Papers, 1911-1934. A resident of Bicknell, Indiana, Harry Valentine was a lawyer and member of the Socialist Party. Contains correspondence, pamphlets, legal papers and newspapers. (See finding aid.)

31) Rose Ladies Aid Society

Records, 1871-1911. Records of the Rose Ladies Aid Society of Terre Haute. This organization provided aid to needy families especially elderly women. Annual reports, financial reports, receipts, misc. items. (See finding aid.)

32) Eaton Family Papers, 1823-1920

Papers of a prominent family from Lawrenceville, Illinois. Contains Civil War letters of James Eaton as well as his memoir on a trip to California. Many receipts, bills, invoices of an early era in Illinois.

33) J.J. Cooper Papers

Typed letter, 1884 (railroad travel). (See finding aid.)

34) Joseph Kimmell (1887-1971)

Papers, 1930-1945. Official and personal papers of a leading political figure and Democratic Mayor of Vincennes during the Depression Era. Includes Kimmel Orchards records, 1929-1945. Correspondence and receipts of the Kimmel Orchards, Vincennes, Indiana.

35) Kimmell & Shake

Papers from the law office of Joseph Kimmell and Judge Curtis G. Shake, of Vincennes, Ind., including correspondence with the Baltimore and Ohio Railroad, for whom the firm eventually worked, account books, and many cases of miners' claims prior to workmen's compensation. Gift of Curtis Kimmell and Curtis G. Shake.

- 36) Abraham Smith
  - Papers, 1828-1894. Letters and papers of a one-time sheriff of Knox County, Indiana. Indentures, deeds, Civil War letters, and other documents. (See oversized box.) (See finding aid.)
- 37) Hosea Smith

Letters, 1810-1823. Letters of an early settler in Knox County, Indiana Territory. Much information on economic conditions, Indian troubles, military movements and descriptions of land. Typed copy. (See finding aid.)

38) Judge Curtis Shake

Papers, 1912-. Papers of an internationally prominent Vincennes lawyer. Shake served as a State Senator, Chief Justice of the Indiana Supreme Court, as presiding Judge at the Nuremberg War Trails, and President of the Board of Trustees at Vincennes University. Collection of papers of interest to the development of historical sites in Vincennes as well as correspondence, photographs. (See oversized box.)

39) Maria Creek Baptist Church Records

Minutes, 1809-. Minutes and papers of the Maria Creek Baptist Church begun in 1809 in northern Knox County.

40) Gottfried Family Papers

Gottfried, John (1873-1968). Small collection of letters and documents of a German family who settled at Billett, Illinois, in 1919. Letters written during World War II represent a look at the simple life to be found along the Wabash River. (See finding aid.)

41) Purcell Family Papers (1900-1936)

Papers of George Purcell, administrator of the estate of William Purcell of Vincennes, Indiana. Letters relate some of local happens around Vincennes in the mid-1930s.

42) Napper Family Papers, 1917-1954

Fine collection of World War I letters of Clifford Napper who served with the 38<sup>th</sup> Infantry USA. Napper also served with army of occupation in Germany. Also Korean letters of William Napper (1953-1954)

- 43) Dunn Family Papers (now moved to RHC 459)
- 44) James D. Williams

Papers, 1840-1880. Small collection of court documents (1840s) and later (typed copies) speeches he made while running for Governor of Indiana in 1876. (See Williams collection in **RHC #4**.)

- 45) W. H. Brevoort (Transferred to RHC 452)
- Spring Hill Church of Christ (Mt. Zion), Lawrence County, Illinois.
   1825-1913. Typescript of church historical materials, notes, roster of members.
- 47) Aurelius M. Willoughby

Diary, 1861-1865. Typed copy of a Civil War diary of Aurelius Willoughby of Company H of 39th Indiana.

- 48) F.X. Burke "Cotton" (possibly merged with other collections below)

  See correspondence in RHC #306 and large Burke collection RHC #312.
- 49) Benjamin V. Beckes Papers (SEE RHC #127, RHC#562, Isaac Beckes Family Papers Collection, green storage shelves and locked archive room.)
  - 1829-. Correspondence, original and photocopies.
- 50) Hyacinthe Lasselle

A letter from Lasselle to Capt. John E. Martin telling him of his properties for sale in Vincennes and price of each lot. Letter includes a map of property. Also an 1838 deed of sale between Lasselle and Lewis Watson. (oversize collection)

51) Frank Scott

Letter, 1868. Letter from Frank Scott, resident of Vincennes, to his sister. Letter tells of conditions in Monument City, Kansas, and at Fort Hays. Scott buys life insurance and makes out his will in case of his death, which could be any time due to the conditions in the "wild west."

52) J. Feverston

Letter, Feb. 15, 1863. Letter of James Feverston, Co. B, 87<sup>th</sup> Illinois, describing the scene in and around Memphis, Tennessee. Feverston was from Edwards County, Illinois.

53) Andrew Berry (1792-1857)

Letters, 1857-1861. Five letters of Andrew and Mary Berry (1796-1867) written from Berrysville, Indiana, to their son, John, at Louisville. Letters tell of conditions in Berrysville (now Wheatland) prior to the Civil War.

54) Church of Christ, Bridgeport, Illinois, minutes – 1866

Five-page handwritten copy of the organizational meeting of the Elders for the Church of Christ, Bridgeport, Illinois.

55) Benjamin Gibbs Account Book, 1783-1847

General store account book of Benjamin Gibbs began in Litchfield, Mass., and carried forward to Lawrence County, Illinois.

- 56) North Side State Bank
  - 1 Vol. 1921-1923. By-laws, minutes of Board of Directors, and names of stockholders are recorded in corporation record book.
- 57) City Junk Co., Vincennes, Indiana "Articles of Association," December 1920.
- 58) Dr. John R. Mantel (1815-)

Account books, 1865, 1873. Two pocket-size diaries of Dr. John Mantel, physician of Vincennes, Indiana. Diaries were used for recording personal expenses and income.

- 59) J. & H. Ostendorf Jewelers (CHECK FOR MORE, LATER ARCHIVES)
  Ledger book, 1863-1894. Ledger of accounts of the John A. and Herman H. Ostendort Jewelry company,
  Vincennes, Indiana. Photocopies and originals.
- 60) Francis Vigo (1747-1836) Papers

Papers, 1787-1834. Photocopies of several letters and documents of Francis Vigo, merchant and fur trader of Vincennes, Indiana. Letters deal with the trading business and the documents concern land sale. Also original document giving Robert William a license as retail vendor.

- 61) Round Prairie Christian Church, 1842-1868, 1 vol. (unclear notation to **see RHC #178**) Wabash County, Illinois. Membership list from foundation of church in 1842 until 1868. Also diary of J. McMillan, minister of the Gospel.
- 62) Vincennes Colorific Brick & Tile Mfg. Co.
  Ledger, 1879-1884. Ledger of the Vincennes Colorfic Brick and Tile Manufacturing Company.
- 63) James M. Musgrave

Poetry, 1857-1862. Poems written in notebook owned by James N. Musgrave, Lawrence County, Illinois.

- 64) Grand Army of the Republic (G.A.R.), Post 681. Lawrenceville, Illinois Record. Description book of Post #681, Department of Illinois, G.A.R, at Lawrenceville, Illinois. Lists names, ages, birthplaces, occupations, military histories, and death dates, if known.
- 65) John K. McCleane, Account Book, 1862-1872.

Account book of John K. McCleane, Lawrence County, Illinois, listing receipts taken in regard to various estates. Estates listed include Albert Badollet, Eaton and Lewis family.

- 66) Christian Church, Allison
  - 1885-1903. Copy of minutes, list of members, finances, of the Allison Christian Church, Allison, Illinois.
- 67) Bridgeport Athletic Club

Records, 1913-1918. Financial record of the Bridgeport Athletic Club, Bridgeport, Illinois. Lists income and expenses as well as record of individual members.

- 68) Buckles Fire Insurance Agency
  - Records, 1920-1924. Financial records of the Buckles Fire Insurance Company, Vincennes, Indiana, listing to whom policy was issued and amount of premium.
- 69) Bridgeport Christian Church

Records, 1900-1908. Record and Register of the Sunday School classes at the Bridgeport Christian Church. Lists students' name, grades, amount of collection.

- 70) Knights of Pythias
  - Membership list, 1888-1891. Membership list of a secret society known as Knights of Pythias, Vincennes, Indiana. Contains list of members' names and dues paid.
- 71) Barr Family Papers

1852-1913. Collection of indentures, deeds, and an account book of the Hugh Barr family, Bruceville, Indiana. Account book of general store (1866).

- 72) P. Bible, Account Book (Ledger)
- 73) St. Thomas Catholic Church

History, n.d. Miscellaneous articles and statements concerning the establishment of both St. Thomas and St. Rose Catholic churches south of Vincennes. Both were early French churches.

- 74) Sieur Claude Drouet de Richardville
  - Report, 1739. Report in French by Richardville, a French military official, telling of the engagement between an army of soldiers from the Illinois Country and the death of Sieur De Vincennes (See Durin, Indiana Historical Society publications, Vol. 8, No. 2, 1924).
- 75) Sieur de St. Ange, Louis Bellerive Documents, 1764-1765. Four Documents in French concerning St. Ange, Commandant at Vincennes from 1736-1765.
- 76) Peter Valley
  - Letter, 1863. Civil War letter of Peter Valley (company and regiment unknown), who was stationed in New Orleans in 1863. Valley describes conditions in the city and notes the price of food items.'
- 77) Deloriea (?)- General Store
  - Account book, 1842. Photocopy of an account book of a general store near Vincennes. Store was owned by a man named Deloriea. Gives prices of farm products and whiskey.
- Minutes, 1871-1907. Organization, By-Laws, minutes of Board of Directors of the First National Bank of Vincennes.
- 79) (McClure) Land Indenture (not found, folder does not exist)
- 80) Old Town Lot #281, Documents

78) First National Bank of Vincennes.

- 81) Claude E. Gregg Papers
  - Paper, 1920-1931. Files of an attorney and Mayor of Vincennes, Claude E. Gregg. Most of the collection concerns Gregg's work with the B&O Railroad. Some correspondence on Clark Memorial.
- 82) Sonderman General Store
  - Records, 1855-1911. Fine collection of general store records from Ferdinand, Indiana, an early German settlement. Both receipts and account books are in the collection and give an excellent look at prices in this community.
- 83) Grayson Collection
  - Papers, 1906-1965. Papers, documents, speeches, and other misc. items of John Grayson, attorney and former Mayor of Vincennes. Material on VFW also in collection.
- 84) Walter Rinderle, the Rev.
  - Papers, 1968-1969. Small collection of research materials on white racism in Evansville, Indiana. Some correspondence, note cards, and pamphlets. Also unpublished paper on "White Racism Among People Especially Catholics, of the Evansville Diocese."
- 85) Hillcrest Hospital (Knox County Tuberculosis Hospital)
  Records, 1937-1971. Financial records of Hillcrest Tuberculosis Hospital, Vincennes, Indiana. Annual reports, Field Examiners reports, By-Laws and Constitution, short history and newspaper clippings.
- 86) A.A. of I.S. & T Workers (Amalgamated Assoc. of Iron, Steel, & Tin Workers)

  Papers, 1907-1923. Small collection of papers of a union member in Vincennes. Collection contains some letters and several small pocket-size notebooks concerning labor problems and members list and dues paid.
- 87) Bruceville (Indiana) State Bank

Records, 1915-1944. Important collection of banking records of a small town bank. Collection contains minutes of Board, daily cash statements, daily journals, and other financial records.

88) Earl C. Lawson (1897-1970)

Papers, 1933-1970. Correspondence of Earl C. Lawson, Mayor of Vincennes, Indiana, from 1964-1970. Lawson was a Republican and his letters reveal a glimpse of party politics in the city.

89) Louis L. Watson (1809-)

Account book, 1837-1839). Account book of Louis L. Watson, prominent resident of Vincennes. Watson ran a tailor shop, saloon, general store through these years and this book is a good record of the price of goods and services.

90) Mathesie-Buck Family Papers (1860-1954)

Fine collection of household and personal account books of the Mathesie family, Vincennes, Indiana. Papers of C.G., Amanda, and Nellie Mathesie present an interesting account of life in the last half of the 18<sup>th</sup> century.

91) Elijah E. Sanford (1853-1918) Papers

Personal papers (1879-1907) of the Rev. Elijah E. Sanford, Minister for 8 years with Maria Creek Baptist Church, Knox County, Indiana. Collection contains three account books recording the number of sermons given at the various Baptist Churches in the area as well as funds collected from these churches.

92) Vincennes Documents, 1772

Photocopies and typescript, some correspondence of historical research; petition from people of Vincennes to General Gage, Sept. 18, 1772; correspondence between Vincennes historian Mrs. Harry Watts and others concerning her research.

93) H.A.M. (Sam) Johnson

Letters (1838-1858). Fine collection of letters from "Sam" Johnson to his wife while searching for gold in California in the early 1850s. Also letters of Eda David and other members of the families of Hancock County, Illinois.

94) Adam Gimbel

Letter, 1883. Letter from Adam Gimbel to the Bridgeport, Illinois, Lodge #386 F. & A.M. regarding the renting of a hall for their meetings. (See RHC #349.)

95) Rose Schultheis Papers (1930-1965)

Fine collection of letters and papers of local Vincennes, Indiana history. Mrs. Schultheis was a prominent citizen of Vincennes and interested in the history of her town. Correspondence with many notable historians in the Midwest.

- 96) James Hodgen
  - Estate, 1822. Sale bill of the estate of James Hodgen in Knox County, Indiana, in 1822. List of possessions and selling price.
- 97) Enoch Richard Steen (1836-1881)

Diary, 1865. Typed copy of the E. Richard Steen diary for the year 1865. Mostly concerning events on the local Knox County scene with little comment on end of War or death of Lincoln. Later Steen records trip to Montana.

98) James Nelson Shepherd

Diary, 1861-1862. Typed copy of a short diary written by James N. Shepherd of Company K. Thirty-first Indiana Regiment. Civil War.

99) Jesse B. Connelly (1836-1920)

Civil War diary, 1861-1863. Civil War diary of Jesse B. Connelly, Company I, Thirty-first Indiana Regiment. Connelly fought with General Grant in many of the important Western campaigns and was later wounded at the battle of Chickamauga.

100) Civil War Diary (1865)

Well-written diary by an unknown author. Writer fails to name company or regiment, but was on march through Mississippi and Alabama at the time of Lincoln's Assassination. Original and typed copy.

101) Minutes of Board of St. Gabriel's College

Minutes, 1841-1848. Typed copy of the minutes of the Board, St. Gabriel's College, Vincennes, Indiana. School was established in 1837 and lasted some eight years.

102) Fr. John Francis Rivet (1747-1804)

Fine descriptive letters of early Vincennes, Indiana, by Fr. John Francis Rivet, who was sent to this French outpost in 1795 by the U.S. government in an attempt to pacify the Indians. Fr. Rivet opened the first school in Indiana.

103) Blackford Window Glass Company

Minutes, 1922-1969. Minutes of the Board of Directors of the Blackford Window Glass Company, Vincennes, Indiana. Blackford moved from Hartford City in 1903 and remained open until 1969.

- 104) Vincennes University Land Documents (missing, no folder, checked Feb. 2017)
- 105) Union Working Men's Assoc. Library

Records, 1857-1935. Records of one of the several Working Men's libraries established in Indiana in the midnineteenth century. By-laws, Articled of Corporation, minutes of board, books bought and price, users' names, fines charged.

106) Glen H. Allen (1899-1973)

Papers, 1933-1938. Small collection of letters and other papers of a District Engineer, Indiana Highway Department, Glen H. Allen, Vincennes, Indiana. Collection also contains photograph albums and an oral history memoir on the highways of Knox County.

107) Vincennes Electric Railway Company

Records, 1921-1939. Articles of Incorporation, By-Laws, Minutes of the Board of Directors of the Vincennes Electric Railway Company.

108) Pleasant Hill Christian Church, Lawrence Co., Illinois

List of names of those attending the Pleasant Hill Sunday School Day Reunion on Sept. 20, 1899.

109) George Klein Memoirs

N.d. Short memoir of a trip to Washington, Indiana, from Vincennes in the late 1920s, written by George Klein, prominent Vincennes, Indiana citizen. Interesting comments on roads and conditions at that time.

110) Azel Kime

Account Book, 1870. Small pocket account book kept by Azel Kime of Union, Indiana. Value only for the names of individuals in surrounding community.

111) Photocopy of 1863 Diary

Apparently anonymous author; Indiana regional references such as Evansville; frequent hospital references.

112) Young Men's Lyceum Minutes, Paris, Illinois

Minutes, 1857-1858, 1860-1862. Minutes of a debating society in Paris, Illinois. List of members, officers, and topic of debate. Name was changed to Paris Lyceum in 1862.

113) Father Pierre Gibault

Letter, 1770 (date unclear). A typed letter from Fr. Pierre Gibault at Post Vincennes to Monseigneur Jean Oliver Briand, Bishop of Quebec, written in late 1769 or 1770. Gibault writes of conditions at Vincennes several years after the conquest of the post by the British.

114) Vincennes Flying Club, Inc.

Minutes, 1931-1934. Minutes of the Vincennes Flying Club for 1931-1934. List of members present, officers, activities of club and master card showing members flying time.

### 115) Peter J. Burns Papers

Letters, 1911-1934. Letters of Peter J. Burns, resident of Vincennes, Indiana, and local historian. Letters to Burns were usually answers to his question on some historical fact of the past.

# 116) Vincennes Commons Land Case Papers

Papers, 1820-1876. Case of Vincennes University against city of Vincennes for sale of Vincennes Common Lands and non failure of the city to turn over funds to the University.

# 117) Knox County Deeds & Indentures

118) Postelwaite & Case, Acct. Book, Wall painter Hanger, & Painter, 1919 (Ledger)

Account book, 1919. Record of Mary F. Postelwaite and Ulysses G. Case, painters and wallpaper hangers in Vincennes, Indiana. Lists names, prices, and work completed.

# 119) Foulks Family Papers

Papers, 1850-1970. Correspondence of a prominent Vincennes, Indiana, family. Letters of Hiram and Mary Foulks, their children: Charles, William, Hiram Jessup, Frank, Robert and George. Hiram Foulks (1832-1922) once served as County Auditor and County Recorder. Family papers, letters, legal deeds.

### 120) Minnie Warner Papers

Letters 1897. Letters of Minnie Warner to her husband while a resident of the West Baden Springs Hotel. She tells of conditions at this famous health resort and of her daily progress and improvement.

#### 121) Eliza Emmons Kinman

Reminiscences of past in Vincennes, Indiana Area.

122) George Rawlinson Family Papers (1828-1906)
