The more accurately you complete the FAFSA (StudentAid.gov) and promptly submit any follow-up documents we request, the more quickly we can determine your eligibility and financial aid offers. We encourage families to use the IRS Data Retrieval Tool available when you file the FAFSA. All federal aid, including student and parent loans, all state aid, and many scholarships require families to complete the FAFSA.

How to avoid some common errors that hold up processing your FAFSA

- 1. Read and follow directions carefully. Take your time. Parents: If you are completing the FAFSA for your student, remember "you" and "your" refer to the student. Especially in the income and tax section, your student did not file a tax return that is identical to yours. The more accurately you complete the FAFSA, the more quickly we can determine your award.
- 2. Student, make sure your name and Social Security number match those on your Social Security card, and make sure your birth date is correct. Be careful to have last and first names in correct order as asked for on the FAFSA.
- 3. Make sure Vincennes University (college code 001843) is on your list of colleges.
- 4. As you get to the financial information section, use the IRS Data Retrieval process if presented to you. Be sure to click the boxes that show you want to "transfer the IRS data to your FAFSA", then do NOT change any of the data. If you can't use the IRS Data Retrieval process, follow directions about which lines to use from the federal tax return you filed. For the 2022-23 FAFSA, use 2020 income and tax information.
- 5. If you do not or cannot use the IRS Data Retrieval, note that one question asks for your (the student's) adjusted gross income, and another question asks how much tax you paid. Do NOT put the same figure for both questions. You did not pay all your income in taxes.
- 6. If you need to provide information about your parent(s), make sure parental name, Social Security number, and birth date are correct. Confirm these answers with your parent(s).
- 7. If you do not use the IRS Data Retrieval, note that one question asks for parental adjusted gross income, and another question asks how much parental tax was paid. Do NOT put the same figure for both questions. Parents do not pay all their income in taxes.
- 8. If you are a student who does not have to submit parental information, don't forget to complete Step Five and answer all the questions.
- 9. Be sure to follow directions all the way to the end. Take your time. Ideally, you are signing your online FAFSA immediately with your FSA ID username & password. If you have to submit parental information, your parent **must** sign the FAFSA:
 - either your parent must also e-sign using his/her own FSA ID username & password (highly recommended),
 - or you must print out a signature page that a parent must sign. Then you can give the page with the original signature to the financial aid office either in person or by postal mail. We can't take a faxed or emailed copy. Giving it to us causes less delay than your mailing the signature page to the FAFSA processing center.

Be sure to follow the directions to the end in order to **submit** your FAFSA. **The processing center will not process your FAFSA until they have the required signature(s).**

10. If you later submit corrections, be sure you follow screens out to the end to e-sign and then submit the corrections. Both student and parent must sign most corrections.
